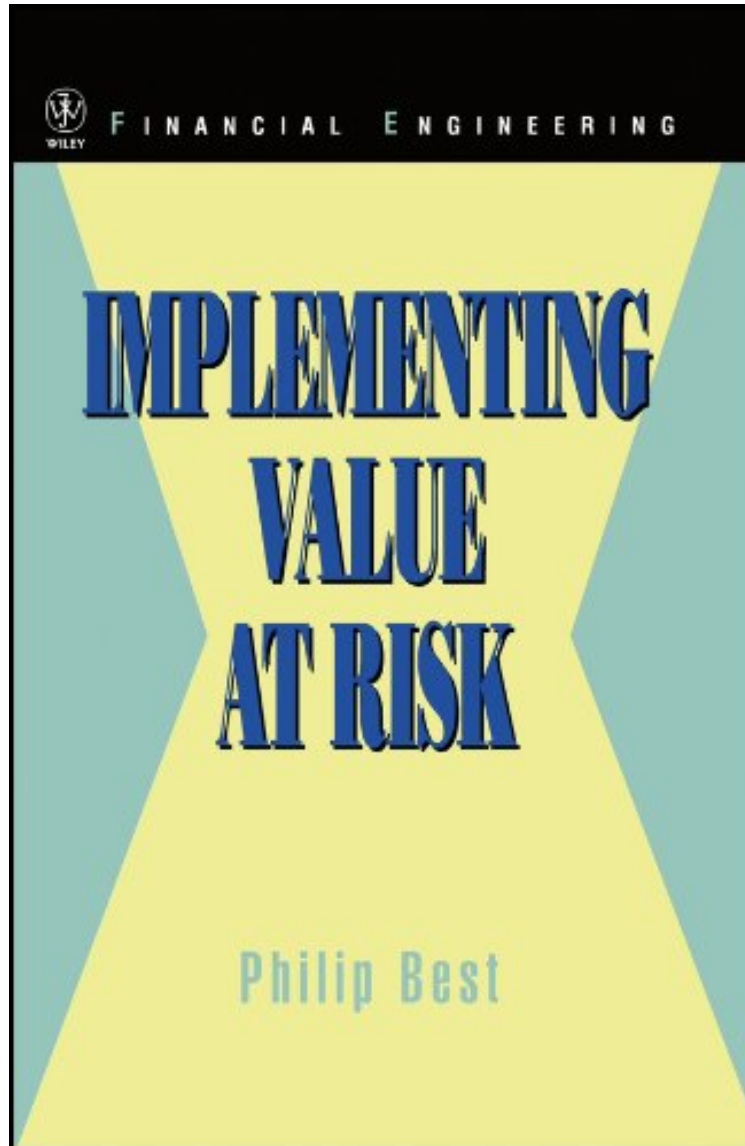

Business concepts are complete. The author gives a lot of weight in risk control. However, he lacks to give detailed examples on how to calculate VAR, the mathematics/statistics behind. Spreadsheets are nice but not complete from the beginning to the end. Important
